Terms and Conditions - Demo Stryk Account

In these terms and conditions (the "Terms"), the following definitions apply:

"Stryk", "Bux", "we", "us" and "our" all refer to BUX Europe Limited, 67 Franklin Roosevelt Avenue, Lima Carna Building, Office 101, 3011 Limassol, Cyprus.

Personal Data means for example your surname, your first name your birthday date, your address.

"Service" or "Services" means the Demo Stryk Account services provided by BUX through the Site, including any new features and applications, subject to the following Terms, as amended from time to time.

"Site" or "Sites" means www.strykapp.com and the Demo Stryk Account application, which can be downloaded from the Apple iTunes app store or the Google Play Store app.

"user", "you" or "your" refers to the person accepting these Terms, the user of our Service and Site.

We reserve the right, at our sole discretion, to change or modify these Terms at any time without further notice. Any such change or modification shall be posted on this page and shall be effective immediately. You should regularly visit our Site and app, to review the current Terms, so that you are aware of any revision to which you are bound. Your continued use of the Service after any such changes constitutes your acceptance of the new Terms. If you do not agree to abide by these or any future Terms, do not use or access (or continue to use or access) the Service. It is your responsibility to regularly check the Site to determine if there have been changes to these Terms and to review such changes.

These Terms are solely applicable to the Services provided by BUX through the Site (Demo Stryk Account) and therefore not to any other service provided by BUX through the Site (including Stryk Live Account) or any other website or mobile application. In addition, when using certain services, you may be subject to additional or different terms and conditions applicable to such services on the Site from time to time, including, without limitation, the Privacy Notice located at www.strykapp.com. All such terms are hereby incorporated by reference into these Terms.

1. Use of Site and Service

BUX grants the user a license for using the Service, subject to the provisions of these Terms. The license is effective until terminated. By installing or using the Service via our Site, you agree to the Terms and agree to be bound by them. You agree that you will also accept these Terms electronically which may include, without limitation clicking on an 'Agree' or similar button or checking a box that is next to or near a link to these Terms and our Privacy Notice.

2. Description of Service

The Service provides a financial markets trading simulation. No actual securities or other financial instruments are purchased, sold or traded as part of the simulation. All information is provided for educational, recreational and entertainment purposes only, and is not intended as investment advice in its broadest sense.

3. No Investment Advice

BUX is not a registered investment adviser, or tax advisor. The Service provides interactive features and general financial information brokerage. These features and this information are intended to inform and educate broad segments of the public and should not be considered as investment advice. Use of the Site and/or the Service is subject solely and exclusively to the laws of the Netherlands. The applicability of any other legal system is expressly rejected. Any disputes shall in the first instance be dealt exclusively by the competent court of Limassol, Cyprus.
